- the criminal records and minor offence records kept by the Ministry of Justice of the Republic of Slovenia;
- the minor offence records kept by competent authorities in the Republic in Slovenia;
- whether a Slovenian authority has initiated a criminal procedure or a minor offence procedure against the alien in question;
- overdue taxes and tax violations, which are kept by a tax authority and classified as a tax secret.
